CE CREDITS MAY BE ORDERED ONLINE AT **OCRAONLINE.ORG** OR BY FILLING OUT THE ORDER FORM AND MAILING TO THE ADDRESS INDICATED ON THE FORM.

INSTRUCTIONS FOR CE BY MAIL

Once you complete the order form and mail to the CE Chairman, you will be e-mailed the link to download the respective file(s) and the written test(s) for each session ordered, or you will then be shipped one DVD and a written test(s) for each session. The written test(s) consist(s) of 20 questions. The pass rate is 70%. If more than six answers are incorrect, you may request to retake the test for a fee of \$10.00. Once you pass the test(s), a Notice of Completion will be issued to you.

If you are applying for Oklahoma CE only, OCRA will mail you a Notice of Completion and a Compliance Form. It is **YOUR RESPONSIBILITY** to complete the Compliance Form and mail to the Administrative Office of the Courts.

If you are applying for NCRA credits as well, the form can be located on ncraonline.org and has to be submitted electronically. It is **YOUR RESPONSIBILITY** to fill the form out online and submit it to NCRA with the Notice of Completion attached.

The Notice of Completion MUST be attached to the Compliance Form to receive credit.
